2. In continuation of the above, I am to state that the 'Tamil Nadu Private Universities (Amendment) Bill, 2024' (L.A. Bill No.43 of 2024), which enables the Government to incorporate the Private Universities in the State through an amendment in the Schedule by the Act of the State Legislature, was passed by the Tamil Nadu Legislative Assembly on 10.12.2024 and upon receiving the assent of the Hon'ble Governor on 09.04.2025, the 'Tamil Nadu Private Universities (Amendment) Act, 2024' (Tamil Nadu Act 12 of 2025) has been published in the Extra-ordinary issue of Government Gazette, dated: 11.04.2025. The copy of the Gazette is enclosed herewith for your kind perusal.

3. I am also to state that as per the above said amendment to the Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act No.14 of 2019), the following 8 Private Universities in Tamil Nadu have been included in the schedule of the Act, with details of location, as per the provision laid down under Section 9 of the said Act: -

1. Dhanalakshmi Srinivasan University
2. Sree Anusuya University
3. Sri Venkateswaraa University
4. NMV University
5. Jeppiaar University
6. Takshashila University
7. Joy University
8. St. Joseph University.

4. I am therefore to request you to take necessary action to include the names of the above 8 Private Universities that were included in the Schedule of the Tamil Nadu Private Universities Act, 2019 (Tamil Nadu Act No.14 of 2019) by virtue of the Tamil Nadu Private Universities (Amendment) Act, 2024 (Tamil Nadu Act 12 of 2025), in the list of Universities, as maintained under section 2(f) of the UGC Act, 1956.
